Campus Security Report 2024

A Legislative History of the Clery Act

The Student Right to Know and Campus Security Act (Public Law 101–542) was signed into law by President Bush in 1990 and went into effect on Sept. 1, 1991. Title II of this act is known as the Crime Awareness and Campus Security Act of 1990. This act amends the Higher Education Act of 1965(HEA) by adding campus crime statistics and reporting provisions for postsecondary institutions. It requires the disclosure of crime statistics for the most recent three years, as well as disclosure of the institution's current security policies. Institutions are also required to issue timely warnings when necessary. All public and private Title IV eligible institutions must comply with the requirements of this act which is enforced by the U. S. Department of Education (ED).

This law was amended when Congress enacted the Campus Sexual Assault Victim's Bill of Rights as part of the Higher Education Amendments of 1992 {Public Law 102–325, Section 486(C)}, giving victims of sexual assault on campus certain basic rights. In addition, institutions are required to develop and distribute a policy statement concerning their campus sexual assault programs targeting the prevention of sex offenses. This statement must also address the procedures to be followed if a sex offense occurs.

An updated version of this law was passed as part of the Higher Education Amendments Act of 1998 {Section 486(e) of Public Law 105–244}. The official title under this act is the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act {20 U.S.C. 1092(f)}. On Nov. 1, 1999, ED issued the final regulations which went into effect on July 1, 2000. The amendments require ED to collect, analyze, and report to Congress on the incidences of crime on University campuses. The amendments also expand the requirement of the Student Right to Know and Campus Security Act of 1990 that all institutions of higher education participating in the federal student aid programs must disclose to students, faculty, staff, and, upon request, prospective students, information regarding the incidence of crimes on campus as part of their campus security report.

The 1998 amendments made several changes to the disclosure requirements. Among these changes were the addition of two crimes (Arson and Negligent Manslaughter) and three locations (residence halls, non-campus buildings or property not geographically contiguous to the campus, and public property immediately adjacent to a facility that is owned or operated by the institution for education purposes) that schools must include in the reported statistics. Institutions that have a campus police or security department are required to maintain a daily crime log that is available to the public.

The Clery Act was also amended in October 2000 by the Campus Sex Crimes Prevention Act (Section 1601 of Public Law 106–386). The changes went into effect on Oct. 28, 2002. Beginning in 2003, institutions are required to notify the campus community where law enforcement agency information provided by a state concerning registered sex offenders who are on campus may be obtained.

On March 7, 2016, President Obama signed the Violence Against Women Reauthorization Act of 2016 (VAWA) (Pub. Law 113-4), which, among other provisions, amended section 485(f) of

the Higher Education act of 1965, as amended (HEA), otherwise known as the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act. The Clery Act requires institutions of higher education to comply with certain campus safety and security related requirements as a condition of participating in the Federal student financial aid programs authorized by Title IV of the HEA. Notably, VAWA amended the Clery Act to require institutions to compile statistics of domestic violence, dating violence, sexual assault, and stalking and to include certain policies, procedures, and programs pertaining to these incidents in their annual security reports (ASRs).

The first ASR that must include this new information is the one that institutions must provide to students, employees, and prospective students and employees by October 1, 2016. The U.S. Department of Education (Department) published a Notice of Proposed Rulemaking including draft regulations that would implement the VAWA changes on June 20, 2016, and expects to publish final regulations by November 1, 2016. Noting this gap, in July 2016, a Dear Colleague Letter GEN-14-13 explaining that institutions must make a good-faith effort to comply with the statutory provisions until the Department has completed the rulemaking process and the final regulations have gone into effect.

Campus Safety

The Campus Safety Office at LPU operates in close collaboration with the Office of Student Life (OSL) and the Office of Residence Life to maintain a safe and secure environment for all members of the University community. Staffed by campus safety associates and supported by contracted security services, the office plays a key role in protecting students, faculty, staff, and University property from crime and safety hazards.

Campus Safety is responsible for maintaining public peace and order on campus. Its core services include assessing safety risks and addressing related concerns, securing campus buildings and facilities, enforcing parking regulations, sharing important safety information, and providing overnight security for campus grounds. LPU does not have any off-campus housing or organizations under the supervision of local law enforcement agencies.

In the event of a crime or emergency that is determined to pose a continuing threat to the University community, a Timely Warning will be issued. This determination is made by the Campus Safety Office in consultation with the Director of Residence Life.

Timely Warnings are distributed to all students, faculty, and staff through the University's emergency alert notification system. Depending on the nature and urgency of the threat, notifications may be delivered via email, voicemail, or text. In situations requiring immediate attention, hard-copy bulletins may also be posted at the entrances of residence halls.

Anyone with information that may warrant a Timely Warning is encouraged to promptly report it to the Director of Residence Life: (909) 706-3092, any Residence Life staff member, or the Campus Safety Office: (909) 706-3088

To report a campus emergency:

- 1. For campus emergencies that are life-threatening, dial 911 first.
- 2. Otherwise, for other emergencies call Campus Safety at 909-706-3088

Upon placing the call for emergency help:

- 1. Give your name, location, and the nature of the emergency.
- 2. DO NOT HANG UP until instructed to do so.

To reach a Residence Life professional for minor issues in campus resident halls that are NOT life-threatening (i.e., lockout, facility failures such as a burst water pipe, alarms, etc.) callers are to be instructed to call or contact the **Residence Offices at ext. 392** using a campus phone **or 909-706-3092** from any non-campus phone.

To reach Facilities personnel for campus emergencies that are NOT life-threatening, callers are to be instructed to call or contact the **Facilities office at ext. 336** using a campus phone or **909-706-3036** from any non-campus phone.

Students and staff may report a crime and request to remain anonymous and/or confidential. This may be done by contacting any of the above staff members. If minor offenses involving University rules and regulations are committed by an LPU student, Campus Safety may refer the individual to the Office of Student Development for disciplinary action.

Life Pacific University's Campus Safety Officers have the authority to ask for the identification of persons on the LPU campus. They do not have arrest authority. LPU maintains a close relationship with the San Dimas office of the Los Angeles County Sheriff. Any criminal activity is reported to the Sheriff as LPU resides within their jurisdiction. All crime victims and witnesses are encouraged to immediately report the crime to Campus Safety and the San Dimas Sheriff. This allows a timely warning to be issued if necessary and ensures accurate reporting.

The Director of Campus Safety prepares this report to comply with the Jeanne Clery Disclosure of Campus Security Policy and Crime Statistics Act. Crime statistics are gathered from reports made to Campus Safety (via the Office of Residence Life) from students, staff and faculty and the local law enforcement agency. The report is published and available to all currently enrolled students, as well as staff and faculty. The report is also made available online on the Life Pacific University website.

Campus Facilities

During regular business hours, the University campus is open to students, faculty, staff, and invited guests. Outside of these hours, access is restricted to authorized students, faculty and staff members who have been issued key fobs and granted permission to use campus facilities.

Residence halls remain secured 24 hours a day. Residents are issued key fobs at check-in at the start of the academic year. These fobs must be returned at check-out; unreturned fobs will be deactivated to maintain security.

Hamilton Hall's main entrance remains unlocked during the posted office hours of the Office of Residence Life, which are displayed on the building's entrance doors.

Campus Safety monitors the physical security of the campus, including exterior lighting, landscaping hazards, and other safety concerns, and reports maintenance needs to the Facilities Department for appropriate action.

Safety & Security Training

During Fall and Spring Orientation, students receive information on LPU's security policies and procedures, including guidance on maintaining personal safety and securing their residence hall spaces. These sessions are designed to establish a strong foundation of safety awareness from the beginning of each semester.

To reinforce these practices, the Office of Residence Life conducts random evaluations throughout the academic year to ensure compliance with campus security policies. These checks may include identifying unsecured room doors, unattended valuables in common areas, adherence to established rules and regulations, and other potential safety concerns.

Faculty and staff are also reminded of campus security protocols at the beginning and end of each academic year. These reminders are typically distributed through the University's official email system to ensure broad and consistent communication.

Drug & Alcohol Policies

Students are not permitted to possess, use/consume, or distribute alcohol, narcotics, and any other form of controlled substance at any time while enrolled at LPU (including all semester breaks). Although students are prohibited from any type of alcoholic drinking, the University has especially low tolerance for those providing alcohol to minors and/or possessing or consuming alcohol while under the age of twenty-one. Such action will subject a student to severe disciplinary action and possible criminal prosecution.

Life Pacific University has the right to disclose any information from the educational records without prior written consent to a parent of students who are dependents for federal income tax purposes (proof of dependency is required prior to release of records). In addition, LPU may disclose to the parents of a student his/her violation of any federal, state, or local law or any rule adopted by LPU governing the possession or use of alcohol or a controlled substance if the student is under age 21. Finally, the University may disclose information from the educational records of a student to his or her parents in connection with an emergency if knowledge of the information is deemed necessary to protect the health or safety of the student or other individuals.

The following information is listed to provide students with information on Life Pacific University's federal compliance with the Drug-Free Workplace Act. Definitions of intoxicants and illegal substances are given.

Federal Mandate

On November 18, 1988, Congress passed the Drug-Free Workplace Act requiring contractors and grantees of federal agencies to certify that they will provide a drug-free workplace. Making this required certification is a precondition for receiving a contract or grant from a federal agency. The federal government then mandated on October 1, 1990, that there will be no illegal drug use by students, staff, or faculty on university campuses anywhere in the United States.

Pursuant to the Drug-Free Workplace Act of 1988, it is unlawful to manufacture, distribute, dispense, possess, or use controlled substances at university work sites and/or while performing University activities, events, or business.

Basis for the Drug and Alcohol Policy

LPU is the oldest institution of higher learning of the International Church of the Foursquare Gospel. As such, the ICFG Statement of Faith serves as a guide for the philosophy of this policy.

Our doctrinal statement includes: We believe in the practical outworking of the life of Christ in the believer so that it will be manifested in good works and holy living.

Students at LPU are committing themselves to training and discipleship towards these good works and holy living. Therefore, because of the known impairing of judgment and harmful effects, students are required to abstain from these substances at least during their enrollment. This abstinence enables each student to focus on their academic studies as well as their personal and spiritual growth and development.

Compliance for Students

The University makes every effort to provide and maintain a drug-free campus. Pursuant to the Drug-Free Schools and Communities Act Amendments of 1989, it is unlawful to manufacture, distribute, dispense, possess, use, or sell illicit drugs and alcohol on campus or during any school-related business or event. All students are required to comply with this policy as a condition of their continued enrollment. Any student violating this policy will be subject to disciplinary action, including possible suspension or expulsion.

In addition to sanctions imposed by the University, students may be subject to regulations of civil authorities. Various local, state, and federal regulations prohibit the illegal use, possession and distribution of illicit drugs and alcohol. Penalties for violation of such statutes vary depending on the type of drug, the amount of drug involved, the type of violation involved, and in the case of alcohol, the age of the person involved.

Alcohol/drug abuse counseling, treatment, rehabilitation, and referral information for Los Angeles County are available in the Office of Student Life as well as in the "Reference section" of this handbook under "Important Numbers."

The University will conduct a biennial review of its alcohol and drug regulations to determine their effectiveness and implement changes as needed to ensure that the sanctions developed are consistently enforced.

Definitions

The use of illegal drugs and tobacco and abuse of alcohol may have serious health consequences, including damage to the heart, lungs, and other organs. Alcohol accidents are the number one cause of death for persons aged 15–24. The most significant health risk, besides death, is addiction. Chemical dependency is a disease that, if not arrested, is fatal.

Illegal drug use or possession may involve, but is not limited to the following substances:

Alcohol

Even low doses of alcohol significantly impair the judgment and coordination needed to operate vehicles. Lesser amounts also lower inhibitions. Moderate to high doses cause marked impairments in higher mental functions, memory, and the ability to learn and recall information. High doses cause respiratory depression and death. Long-term consumption, particularly when combined with poor nutrition, can lead to dependence and permanent damage to vital organs such as the brain and the liver.

If combined with other depressants that affect the central nervous system, even low doses of alcohol will produce adverse effects. Mothers who drink alcohol during pregnancy may give birth to infants with fetal alcohol syndrome. These infants have irreversible physical abnormalities and mental disabilities.

Tobacco/Nicotine

Immediate effects include relaxation and increased confidence and metabolism. However, smokers are more likely than nonsmokers to contract heart disease. Thirty percent of cancer deaths are linked to smoking. Chronic obstructive lung diseases, such as emphysema and chronic bronchitis, are ten times more likely to occur among smokers than nonsmokers. Smoking during pregnancy also poses risks such as spontaneous abortion, premature birth, and low birth weights. Fetal and infant deaths are more likely to occur when the pregnant woman is a smoker. Tobacco/nicotine is both psychologically and physically addictive.

Cannabis: Marijuana, THC, Hashish, Hashish Oil

Physical effects of cannabis include increased heart rate and appetite, bloodshot eyes, and dry mouth and throat. Use of cannabis may impair or reduce ability to drive an automobile or perform tasks requiring concentration and coordination. Motivation and cognition may be altered, making the acquisition of new information difficult. Marijuana, hashish, THC, etc., can

also produce paranoia and psychosis. Long-term use may result in lung damage; reduced sperm count and mobility and affect ovulation cycles. Cannabis can also be psychologically addictive.

Cocaine/Crack

Cocaine stimulates the central nervous system. Its immediate effects include dilated pupils and elevated blood pressure, heart and respiratory rates and body temperature. Occasional use can cause nasal irritation; chronic use can ulcerate the mucous membrane of the nose. Crack or freebase rock is extremely addictive. Additional physical effects include insomnia, loss of appetite, tactile hallucinations, paranoia, and seizures. The use of cocaine can cause death by cardiac arrest or respiratory failure.

Stimulants: Amphetamines, Crank, Ice, Methamphetamines

Stimulants cause increased heart and respiratory rates, elevated blood pressure, dilated pupils, and decreased appetite. Users may experience sweating, headaches, blurred vision, dizziness, sleeplessness, and anxiety. Extremely high doses can cause rapid or irregular heartbeat, tremors, loss of coordination, and physical collapse. An amphetamine injection creates a sudden increase in blood pressure that can result in stroke, exceedingly high fever, or heart failure. In addition to physical effects, feelings of restlessness, anxiety, and moodiness can result. Use of substantial amounts over a prolonged period can cause amphetamine psychosis, including hallucinations, delusions, and paranoia. The use of amphetamines can cause physical and psychological dependence.

Hallucinogens: PCP, LSD

Phencyclidine (PCP) interrupts the functions of the neocortex, possibly resulting in self-inflicted injuries. Users may experience a sense of distance and estrangement, loss of muscular coordination, and speech impairment. Large doses may produce convulsions and coma as well as heart and lung failure.

Lysergic Acid (LSD), mescaline, and psilocybin cause illusions and hallucinations. Physical effects may include dilated pupils, elevated body temperature, increased heart rate and blood pressure, loss of appetite, sleeplessness, tremors, and psychological reactions. Users may experience panic, confusion, suspicion, anxiety, and loss of control. Delayed effects or flashbacks can occur even after use has ceased. Use of hallucinogens can cause psychological dependence.

Anabolic Steroids

Steroid users subject themselves to more than seventy side effects, ranging in severity from acne to liver abnormalities to psychological reactions. The liver and cardiovascular and reproductive systems are most seriously affected by use. In males, use can cause withered testicles, sterility, and impotence. In females, masculine traits can develop along with breast reduction and sterility. Psychological effects in both sexes include aggressive behavior known as "road rage" and depression. While some side effects appear quickly, others such as heart attacks and strokes may not show up for years.

Sexual Assault

The Office of Residence Life partners with Emmaus Road Counseling Center and Clothesline Project to annually educate students and personnel about sexual assault prevention and awareness.

The University is concerned about any allegations of sexual assault and, therefore, strongly encourages any person who has experienced such a violation to report the situation immediately to the Director of Residence Life or Dean of Students who will take action to ensure that appropriate medical and counseling services are provided. Sexual assault is defined as rape, acquaintance rape, and other sex offenses, forcible or non-forcible. Victims of sexual assault should attempt to preserve evidence that may be necessary to the proof of criminal sexual assault.

University personnel will assist the victim in notifying the San Dimas Sheriff's Department if the student so desires. LPU will offer alternative academic and living situations to a sexual abuse victim if so, requested by the student and if reasonably available.

In cases of an alleged sex offense, the accuser and the accused are entitled to the same opportunities to have others present during the disciplinary proceeding. Both parties will be notified of the outcome of the disciplinary proceedings. A student found guilty of violating the University sexual misconduct policy could be criminally prosecuted in the state courts and may be suspended or expelled from the University. However, the University will report and cooperate with the appropriate law enforcement authorities that have the right and responsibility to act in response to law violations committed on the University premises and/or by a member of the University community. The University will report complaints of sexual assault that involve minors to the appropriate law enforcement authority in accordance with California law.

Sexual Offender Registration

The Campus Sex Crimes Prevention Act (CSCPA) of 2000 is a federal law that provides for the tracking of convicted sex offenders enrolled at, or employed by, institutions of higher education. It amends the Jacob Wetterling Crimes Against Children and Sexually Violent Offender Registration Act. The federal law requires state law enforcement agencies to provide Life Pacific University with a list of registered sex offenders who have indicated that they are enrolled, employed by, or carrying on a vocation at Life Pacific University. Counseling Services

Emmaus Road Christian Counseling is a Christian-based psychological counseling program located on the campus of Life Pacific University developed to offer services to the students at Life Pacific University. Individual and group counseling, as well as pastoral counseling, is available at a minimal cost for students. Specific counseling issues include, but are not limited to, interpersonal and sexual concerns, premarital counseling, spiritual concerns, depression, addictions, and eating disorders. Counseling sessions are considered privileged and only the client may authorize the release of information revealed during these sessions. Crime information that the University is required to include in the Annual Security Report which the client reveals during counseling sessions is forwarded as numbers only, name and other privileged information is considered confidential.

Crime Statistics

Although LPU does not experience a large amount of crime, crimes have occurred on or near the campus. The University collects and publishes crime statistics in accordance with the requirements of the Jeanne Clery Act. The statistics are reviewed, and the report is prepared by the Director of Campus Safety.

The collection of statistics includes University personnel who have significant responsibility for student and campus activities. Access to the report is distributed to all University students and personnel, and a link is created on the University's website to aid prospective students, parents, and employees to request a copy.
